OUR MISSION

The Global Centre for the Responsibility to Protect (often referred to as GCR2P or the Global Centre) mobilizes governments and the international community to act in situations where human beings are facing the risk of atrocity crimes: genocide, war crimes, crimes against humanity and/or ethnic cleansing. To achieve this mission, the Global Centre for the Responsibility to Protect advocates for the effective and consistent implementation of the <u>Responsibility to Protect (R2P)</u>, a global political commitment aimed at mobilizing action to prevent and respond to mass atrocity crimes.





OUR THEORY OF CHANGE IN ACTION

The Global Centre has played a leading role in organizing and working with civil society coalitions on advocacy campaigns to prevent, halt, investigate and/or preserve evidence of atrocity crimes.



SYRIA

The Global Centre helped establish the UN's International, Impartial and Independent Mechanism for Syria to support investigations and prosecutions of atrocity crimes in Syria since 2011, in collaboration with Syrian victim and family associations.

ETHIOPIA

The Global Centre identified key gaps in accountability for victims and survivors of atrocities in Ethiopia. To address this, we established a working group for accountability in Ethiopia, bringing together over 40 human rights groups and defenders to collaborate on advancing justice and accountability.

VENEZUELA

For years the Global Centre has worked with Venezuelan civil society to craft and implement strategies aimed at investigating crimes against humanity in Venezuela. This work led to the establishment and regular renewal of a UN Fact-Finding Mission, which contributed to the opening of an International Criminal Court investigation.

MYANMAR (BURMA)

Following the 2017 genocide of the Rohingya population by the Myanmar military, the Global Centre worked with partners to identify and support The Gambia in filing its complaint at the International Court of Justice against Myanmar for violating the Genocide Convention.

CENTRAL AFRICAN REPUBLIC

From 2013-2014 the Global Centre was one of the only organizations that framed the situation in CAR from an atrocity prevention lens. This framing and subsequent call for civilian protection led to the creation of a UN peacekeeping operation with a strong protection of civilians mandate.

SUDAN

The Global Centre was among the first organizations to alert the UN Security Council about the possible risk of genocide in Darfur in 2023. Our urgent alert and advocacy with Sudanese human rights defenders were crucial in securing a UN Security Council resolution calling for an immediate halt to the siege of and genocidal violence in El Fasher.

OUR TOOLBOX



RESEARCH & MONITORING

The Global Centre has monitored and researched over 60 countries around the globe and currently produces real time analysis on the risk of atrocities to populations in more than 25 countries.



TRAININGS & CAPACITY BUILDING

We train government officials, including diplomats, embassy officials and other policy enablers and decision makers, as well as peacekeepers, to make them aware of the tools and tactics they have in their arsenal to prevent and halt mass atrocities.
